As human rights abuses against women, girls, and gender-diverse people with disabilities are on the rise and anti-rights and anti-gender movements are gaining momentum, their work is now more vital than ever.

At the same time, shifting priorities of billateral, multilateral and private funders have transformed the funding landscape.

### Historically Underfunded

Gender and disability advocates—already historically under-resourced—are facing even greater challenges in securing financial resources for advancing the rights of their communities.

Despite the fact that one-fifth of the world's population of women have a disability, data shows a lack of intersectional rights-based funding.



In the US

#### Just 0.1% of the grants

from U.S.-based foundations advance disability rights and iustice



Globally

Only 4% of \$1.2 B in women's rights grantmaking by private foundations targeted women with disabilities

Less than 30% of **\$177.9M** to advance disability rights targeted women with disabilities


#### To break these patterns funders can:

A global survey conducted by Women Enabled International in the first weeks of 2025 drew responses from more than 50 organizations working on gender issues, disability rights and/or their intersection.



The already precarious funding landscape is rapidly deteriorating, negatively impacting the continued work of organizations, as well as the lives of women, girls, and gender-diverse people with disabilities around the globe.

At least 10 organizations working at the intersection of gender and disability rights report they have ceased all operations.

"We have been forced to cease all operations despite having secured two critical grants [from the US government]"

37 organizations report being forced to stop at least some programmatic work, layoff staff, and alter fundraising strategies.

"The critical services we provide to people with disabilities are at risk of being disrupted, and we are struggling to keep our mission alive due to uncertain funding sources."

Even organizations that have not been directly financially impacted yet, particularly those based in the U.S., anticipate and are preparing to face significant challenges in the future.

"We have not experienced cuts yet, but we think we might still experience cuts to federal grants going forward. We are trying to prepare..."

Some respondents emphasized that the current context not only has financial implications for civil society but has also created a climate of fear and uncertainty about the future.

"What is happening not only limits the organization's activities and work plans but also affects our mental health."
